WHEN REMOVING A TREE, THE STUMP MUST BE PROPERLY REMOVED AS WELL.

ONLY CERTIFIED ARBORISTS WHO ARE LICENSED IN WILSON BOROUGH MAY DO THE WORK. ONCE THE APPLICANT HAS SIGNED OFF ON THE APPLICATION, THE ARBORIST MAY THEN SIGN AND SUBMIT THE APPLICATION TO THE WILSON BOROUGH CODE OFFICE.
