### LETTER FROM THE MAYOR - DONALD R. BARRETT, JR

While 2021 has been a challenging year, and we have had a lot of ups and downs, it was, overall, a good year. We started out the year with the residual impacts of the COVID 19 pandemic and ended with community events and people finally able to gather again safely. We Celebrated 100 years as a borough (plus 1 year of course), attended sporting events at capacity and are starting to return to normal. Just because things look better socially, however, doesn't mean they are across the board. A lot of businesses were impacted here in the Borough, and this will definitely have us adjusting for the next few years so that we can recover fully. To accomplish this, we will need to make choices as a council that will impact our community and our future.



Budget time is never fun, and 2022 is going to be a challenge. One of the good things about Wilson Borough is our lack of debt service. We have NO outstanding loans and are excellent at paying our bills. Our front office works hard to bring in money but also keep us on the plus side, ledger-wise. With the aforementioned impacts to businesses, it comes down to making decisions that may be hard for some. For example: do we postpone fixing the swimming pool or replace a 30-year-old firetruck? These are the types of tough choices that we will need to make. The Sale of Easton Hospital to St Luke's for which I am extremely thankful, also adds to the impacts on our tax base.

Sure, it is easy to say let's make some cuts in our departments, personnel, budgets, etc., but until you look over everything any minor cuts can have a huge impact. Last year we saw crime go to the lowest it has been in a while. I read some posts that declared it was "time to move", but looking at the numbers, crime is down over consecutive years. In 2017, there were 338 Part 1 Offenses; currently, we are at 128. These improvements are not just part 1 offenses; we have seen these totals drop year after year across the board. So, do we risk cutting police resources knowing there has been a recent positive impact (and I can say it is directly because of our Police Department). They have fought to keep Spanky's closed and do a lot more that we don't see. The police department also received approximately \$160,000 in grants obtained by our chief and engineering firm to help keep us moving in the right direction.

Our Fire Department answered a total of 625 calls (EMS and Fire combined) and in an average call time of under 5 minutes. It takes about 2.5 minutes to be enroute. Our ladder truck, however, is currently in bad shape and will cost us about a million dollars to replace. We are able to cover this expense with a CD. I believe that this is something the Borough desperately needs to keep its residents safe.

After last Winter, I don't think we can afford cuts in Public Works. Yes it may have taken a bit longer than folks would have liked for alleys to be cleared, but we had an incredible winter storm

last year and they did an amazing job under those extreme circumstances. In my travels for work and seeing other towns, I can vouch firsthand that they did an amazing job.

We have also seen a warehouse project put on hold and concerns coming from neighboring communities about traffic it would generate. These same communities continue to build retail space and housing along an already congested area. This warehouse project will clean up a toxic waste area and daylight a stream that has been covered for over 100 years (the wetlands in the article) as well as bring badly needed revenue to the area. None of this could be done without PennDOT approval and they would have made sure the impacts to the roads and traffic were addressed. Of course, the other “albatross” (these are Northampton County’s words, and I agree) is the Dixie Building; litigation cannot get here soon enough on this property. We need this property working for Wilson Borough and its residents and the same old story that this has been going on for the past 30 years and “is what it is” needs to end now. We added another filing to the original lawsuit asking for a cease and desist on all activities and use of the building until something is done immediately to clean it up. It is unsafe, and an eyesore, but condemning or exercising eminent domain would put a burden on the Borough that we do not need to bear or deserve. The sad part is that many of the projects in other areas could have been part of Wilson Borough, but all we have now is an empty cup. In 2020 the state lifted the restrictions on boroughs from having Redevelopment Authorities. I would like to see if we can work with the County to establish a redevelopment zone in Wilson Borough.

In closing I am going to circle back to our Celebration. Wilson Borough has survived 100 years and seen its fair share of adversity, and I am sure this will not be the last of the issues. The Celebration was pulled off by a very small group of hard-working and dedicated people. We may be a small borough but it doesn’t mean we can’t make a difference. It comes down to how bad we want the change. Complaints are just words that express dissatisfaction or annoyance about something. Actions speak louder than words. If you want to see more events, or if there is something that you feel can be improved upon from this year, I strongly encourage you to join the Celebration committee. If you are sincerely worried about crime, create or join a block watch group. If you are concerned about kids trampling your flowers, coach, or volunteer to work with youth in one of the many community sports organizations we have! Turn your negative concerns into positive outcomes! You can impact this community. Make it what you want; don’t simply rely on us to do it all. On that point:

# WILSON BOROUGH CODE ENFORCEMENT OFFICE

Did you know that all our ordinances are codified and online for all to see? Wilson Borough uses eCode 360 to publish and maintain all our ordinances. The ordinances are organized by chapter and are both searchable and printable. New ordinances are added upon adoption. You can find them by visiting the Borough website, under the Departments/Code Enforcement tab. If you have any further questions, please contact the Codes and Zoning Department at 610-483-2315.

## CODE PROCESS

Over the years, residents have asked about the Code Enforcement process and why it appears to take a long time for a resolution to a Code issue. This is just an overview; the actual process can be quite involved and time consuming!

It either begins with a complaint from a resident or an observation by Code Enforcement. The information received is reviewed against the Borough's Codes to verify that a violation does exist.

A letter is sent to the owner or occupant of the property explaining the issue, the code violated and a time to resolve it by. Most times, this is the all that needs to be done and the matter is taken care of. After a follow up, if the matter is not resolved additional notices are sent to resolve the violation. If those notices are ignored, the property is posted with a copy of the sent notice(s) and timeframe by which the issue must be resolved. Where these attempts do not result in a resolution to the matter, a Citation or Civil Action is filed with the local District

Justice. Should the defendant plead guilty and remit the fine to the Court, the matter is closed, even though the violation remains. If the defendant requests a hearing, one is scheduled before the District Justice. If the outcome of this hearing is a guilty verdict, a fine is assessed only and the defendant has thirty days to appeal the verdict to Common Pleas Court. If the defendant does not appeal after the thirty days, the fine must be paid. For the Borough to have the violation resolved, an enforcement action must be filed in Common Pleas Court. For an appeal at the Common Pleas level, the hearing process begins all over again and the previous fine is set aside. At this hearing, the Judge may uphold the District Court decision for the fine or overturn their decision.

Again, it is only a fine, an enforcement action may still be required to compel compliance with the Codes. This whole process can take a lot of time, but it is what the Code Enforcement Department is required to do as part of the enforcement process to gain compliance. -

# CODE FEE SCHEDULE

ALL FEES EFFECTIVE JANUARY 1, 2020

## Home Inspection

- Each dwelling unit to be inspected is \$100
- Each Commercial or Industrial use under 5,000 square feet to be inspected is \$125 per building.
- Each Commercial or Industrial use over 5,000 square feet to be inspected is \$175 per building.
- Certificate of Occupancy is \$50.

## Building Fees

- \$25 for the first \$500 and \$2.50 for each additional \$100, not to exceed \$10,000.

## Electrical Fees

- \$25 for the first \$500 and \$2.50 for each additional \$100, not to exceed \$10,000.

## Plumbing Fees

- \$25 for the first \$500 and \$2.50 for each additional \$100. not to exceed \$10,000.
- The tapping fee will be \$1000 to access and utilize the sewer line off of the Property, \$500 if the line is within the Property boundary.
- There must always be a Master Plumber on the job, duly licensed by the Borough of Wilson.

## Trenches and Excavations

- \$10 per square foot of restoration.
- Permit fee \$25

## Demolition

- Residential \$8 per square foot
- Commercial \$8 per square foot

## Street Signs

- Handicap parking \$125
- Business directional \$60 (\$160 if a pole is required)
- Business parking \$125

## Business Privilege

- Business Privilege license \$25
- Business Privilege tax: .0015 of gross income earned in the Borough

## Moving Permit

- \$5.00 fee

## Health Inspections and Licenses

- Initial inspection and license \$150
- Renewal (yearly) \$85
- Re-Inspection due to violation \$35
- Temporary license (14 days or less per year) \$10/day
- Nonprofit organizations shall comply with Chapter 78 of the Department of Agriculture Code; however, no fee is required.

## Grass/Weed Cutting or Snow/Ice Removal from private property

- The cost to remove will be passed on to the property owner



## CAREGIVERS OF NORTHAMPTON COUNTY CAN GET ADDITIONAL SUPPORT THROUGH THE CAREGIVER SUPPORT PROGRAM

- Caregivers can receive reimbursement for approved, out-of-pocket caregiving expenses such as respite care, assistance with personal care and consumable supplies such as adult disposable depends and nutritional drink supplements.
- Care receiver is age 60 or older and requires assistance with bathing dressing etc., or under age 60 with a diagnosis of dementia
- Reimbursement is based on the household income of the care receiver
- Assistance for Grandparents who are 55+ and are the primary caregiver for their grandchildren
- Assistance for older adults who are 55+ and are the primary caregiver for their adult children age 18-59 with a diagnosis of a non-dementia related disability.

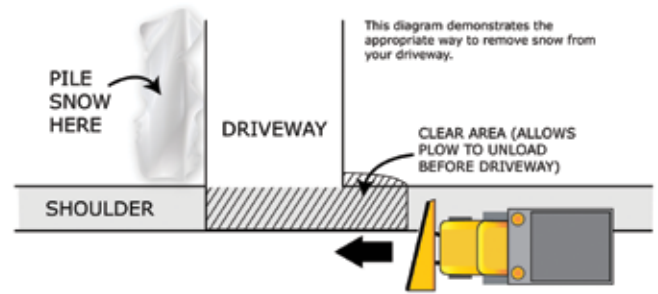


## WHAT IS A SNOW EMERGENCY?

A snow emergency is the term used to indicate the active response plan when a snow storm severely impacts the Borough of Wilson. When a snow emergency is called you have 4 hours to remove all your vehicles from a snow emergency route. The snow emergency routes are listed below.

Cars parked on any posted Snow Emergency Route must be moved when a Snow Emergency is declared. Cars which are not moved will be towed at the owner's expense.

A snow emergency will be advertised on 69 news, WilsonBorough.org, Twitter, Facebook and Nixile. When a snow emergency is called you may park at the tennis courts, Wilson High School parking lot and Jeffrey field. Once the snow emergency is lifted you have to remove all cars from those designated parking areas.

**Just a reminder about inclement weather; When the forecast calls for heavy snow or ice the mayor can declare a snow emergency:**

### Ordinance § 162-18 Declaration of snow and ice emergency:

In order to facilitate the movement of traffic and to combat the hazards of snow and ice on the snow emergency routes named in § 162-20, the Mayor in his discretion may declare a snow and ice emergency, designated in this article as a "snow emergency." The Mayor may declare any snow emergency route or any part of a snow emergency route to be free from restrictions herein imposed when, in his opinion, the weather or street conditions warrant such an exclusion. Information on the existence of a snow emergency may be given by the Borough through radio, newspaper or other available media, and information on the termination or modification of the emergency may be given by use of the same media.

### § 162-19 Parking and driving restrictions on snow emergency routes.

After any snow emergency is declared, it shall be unlawful at any time during the continuance of the emergency for any person:

- To park or leave unattended a motor vehicle or to allow that vehicle to remain parked or unattended anywhere on any snow emergency route designated in § 162-20.
- To drive any motor vehicle on any such snow emergency route, unless that vehicle is equipped with snow tires, chains, all weather tires or studded tires that are approved by the commonwealth.

### 162-21 Emergency towing.

Any vehicle parked, stalled, incapable of moving under its own power or left unattended upon any street designated as a snow emergency route may be removed or towed to any other location by the Police Department at the owner's expense.

If you plan on going out of town during the winter months, please make arrangements with somebody who can move your car if it is parked on a snow emergency route. We do not like towing cars and it is very expensive!

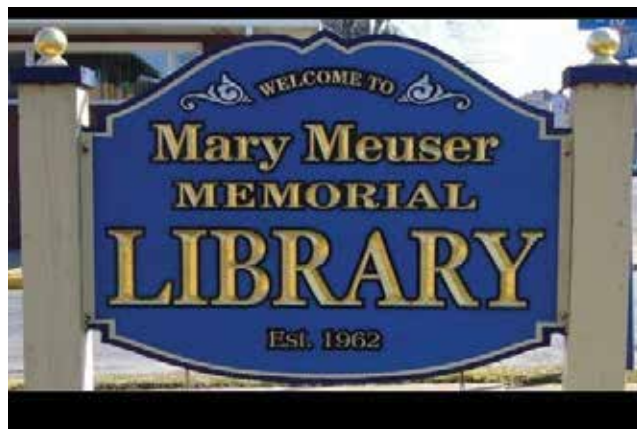
