COMMUNICATIONS FROM THE MAYOR:

Mayor Barrett received a survey from St. Luke's Hospital, Easton inquiring about Wilson Borough's health and fitness; specifically the following question "What improvements and policy and community infrastructure would assist you and your community in meeting your community's health needs mentally and physically?". Mayor Barrett suggested the need for the replacement of Meuser Pool. Solicitor Margle advised with his years of experience with public/private partnerships one of the first questions a public/eleemosynary institution like St Luke's will undoubtedly ask is what the total commitment and completion date for the new pool will be. This would be a premature time to mention the pool.

Ms. Garcia advised Mr. Jones she will make sure a representative from the finance company will be at the next Council meeting. Solicitor Margle and Ms. Garcia are both concerned about inviting the finance company to a Council meeting when Council has not made a commitment to spend the money.

COMMUNICATIONS FROM THE BOROUGH MANAGER:

Ms. Garcia advised a letter was received from Borough Engineer Ms. Monica Wall of T&M Associates. The low bidder for the CDBG Grant project of 46 ADA ramps was G&B Construction at \$197,000. The grant funds came in at \$143,000. this would reduce the number of ramps to 33. T&M Associates is recommending the contract be awarded to G&B Construction. A motion to award the bid to G&B Construction with a total contract award of \$141,471, made by Mr. Lipari. Second by Mr. Woodring.
