WILSON BOROUGH NORTHAMPTON COUNTY PENNSYLVANIA March 8, 2021

The first meeting of March of the Council of The Borough of Wilson was held virtually via Zoom. President Verenna called the meeting to order at 7:00 pm. Roll call followed.

READING OF THE MINUTES:

Motion by Mr. McGowan to approve Council Meeting minutes from February 22, 2021. Second by Mr. Burke. Roll call vote followed. Yes votes were cast by Mr. Burke, Mr. Bracken, Mr. Lipari, Mr. McGowan, Mr. Palinkas, Ms. Taylor, Mr. Verenna, and Mr. Woodring. Motion passed with an 8-0 vote.

COUNCIL VACANCY

Solicitor Margle advised the resignation of Councilman David Jones was received on February 8, 2021 and because of the resignation the applicable law for the Boroughs in the Commonwealth of Pennsylvania applies. Council is to accept letters of interest from individuals. The requirements under the law are 1. Person filling the vacancy must live in the same ward as the resigned Councilman. 2. They must be a one-year resident of the ward. 3. They must be a registered voter in Northampton County. Solicitor Margle advised Council received three letters of interest from prospective appointees; Ms. Shaun Gable, Mr. James Klass and Mr. Mike Shannon, to fill the vacancy. The appointment it is effective immediately and the appointed person will hold the seat until the General Election in November. All three prospective appointees made statements prior to a motion and voting.

A motion made by Mr. Burke to appoint Mr. Shaun Gable. Motion died for a lack of second.

A motion made by Mr. Woodring to appoint Ms. Shaun Gable. Second by Mr. Burke. Roll call vote followed. Yes votes were cast by Mr. Burke, Mr. Bracken, Mr. McGowan, Mr. Woodring. No Votes cast by Mr. Lipari, Mr. Palinkas, Ms. Taylor, and Mr. Verenna. Solicitor Margle advised under normal circumstances a tie vote on agenda matters and normal business falls to the responsibility of the Mayor. In this situation however, Solicitor Margle advised that the Mayor's job in breaking a tie pertains to business and administerial duties rather than the filling of a vacancy. The motion did not pass for lack of majority.

A motion made by Mr. Verenna to appoint Mr. James Klass. Second by Mr. Lipari. Roll call vote followed. Yes votes cast by Mr. Bracken, Mr. Lipari, Mr. McGowan, Ms. Taylor, Mr. Woodring, Mr. Verenna and Mr. Palinkas. No votes cast by Mr. Burke. Motion passes with a 7-1 vote.

Mayor Barrett swore Mr. Klass in as member of Council.

GUEST:

Mr. Johnny Sweeny of Northpoint Development discussed a development project at 1525 Wood Avenue Easton, PA 18042. The project is anticipated to cost close to \$90,000,000 and create around 450 jobs. The building is projected to be approximately 806,000 square feet. Northpoint has submitted a Zoning application and a sketch plan.

Mr. McGowan asked if there is an occupant for the building. Mr. Sweeny advised the buildings are built on spec basis. Solicitor Margle advised Council they will know who the tenant is before the project gets off the ground. Mr. Klass asked about how the stream will be redirected, and will it have any impact on Fisk Field? Mr. David Salinas of Northpoint advised there will be no issue. Mr. Palinkas asked how far the warehouse will be from the residential district near Bushkill Drive? Mr. Salinas advised the distance is in excess of 750 feet and the lighting spillage is called dark night and it is directional. The lighting will not bleed out into the residential areas or any adjacent properties. Solicitor Margle also advised any lighting that goes off site will have to be properly buffered and controlled. President Verenna asked the representatives of Northpoint to come back to Council at a later date to speak again and provide more details.

A motion made by Mr. Palinkas to grant the use of facilities. Second by Mr. Burke. Yes votes were cast by Mr. Burke, Mr. Bracken, Mr. Klass, Mr. Lipari, Mr. Palinkas, Ms. Taylor, Mr. Verenna, and Mr. Woodring. No votes cast by Mr. McGowan. Motion passed with an 8-1 vote.

Ms. Garcia advised use of Meuser Park on June 5, 2021 was requested by the Allentown Corvette club for a second car show however, the next day, June 6, 2021 is the Antique car club. Ms. Garcia would like to know if Council is ok with two car shows back-to-back? Solicitor Margle advised Council may want to consider a formal policy for future issues. This item has been tabled.
