COMMUNICATIONS FROM THE MAYOR:

Mayor Barrett advised residents have reached out to him regarding street trees and sidewalks and questioned who is responsible for them. Ms. Garcia and Ms. Jones advised to have these residents call the Borough Office. Shade Tree rules are also on our Borough Website.

Mayor Barrett advised he received an email about speeding between 25th and 24th Streets on Freemansburg Ave. Chief Meehan advised he will put the speed sign out to help deter speeding.

Mayor Barrett advised a resident with cancer living on the 2100 block of Hay Street would like a handicap parking place however, there are already three on the block. He asked if she should apply for a permit? Chief Meehan advised the Borough ordinance states a maximum of three spaces on any block.

Chief Meehan advised he will be visiting the Lackawanna Police Academy for recruitment purposes.

FIRE:

Chief Sipel requested Council's permission to hire Mr. Kyle McKenna as a part time Fire Fighter/driver. A motion to approve by Mr. Lipari. Second by Ms. Gable. A roll call vote followed. Chief Sipel advised Council he witnessed what looked to be a gasoline tanker parked at the Kmart parking lot. Ms. Jones advised she will contact the Code Officer about the situation.

Ms. Garcia advised the Athletic Commission is a committee of Council and have no by-laws yet, any funds used should be reported to Council. Mr. Bracken suggested any association asking for funds should try to return those funds to the Commission so other associations will have the same benefit and the money given should be on a need basis not a want basis.
