Ms. Garcia advised she received the renewal for the Borough's Worker's Comp insurance. The premium will be going up \$48,000 next year due to the volume of claims.

Ms. Garcia advised the grants for Police station and Administration building will be completed in two phases. Ms. Garcia requested a motion to sign the agreement with T&M Engineering. Cost of the work will be \$16,000. A motion to sign the agreement made by Mr. Lipari. Seconded by Mr. Verenna. A roll call vote followed.
