Mr. Burke is hopeful in the next couple of weeks that things will get ironed out because County did cancel another meeting, which means the IDA did not meet for three months.

Mayor Barrett thanked Mr. Burke for taking time contacting the County. Mayor Barrett expressed dissatisfaction with the County for holding up the Dixie project.

Solicitor Margle advised January 28, 2025, the Zoning Hearing Board will be hearing two applications: 132 S. 17th Street and 2217-19 Forest Street. Solicitor Margle will appear on behalf of Council and encouraged Council members to attend the hearing as well.

Solicitor Margle followed up on Mr. Burke's comment in reference to the IDA moving forward. Solicitor Margle and Mr. Burke have determined that is does not appear the IDA is involved in any delay tactics. It appears to be a result of some actions by the County Council. For whatever reason The County does not want to bring the issues of the IDA and the issues with the Dixie project to a head. Mr. Burke has reached out to Ms. Tina Smith. Solicitor Margle has reached out to two members of County Council.

Ms. Garcia advised she received an email from Attorney Jonathan Cox who stated the IDA is looking for the Borough Planning Commission to pass a Resolution saying the Dixie is blighted. Ms. Garcia asked if the Wilson Borough Planning Commission should act on this or if it is inaccurate. Solicitor Margle stated that it is not accurate.

Solicitor Margel stated that the term blighted carries a specific characteristic and definition under the law. The Dixie building might have been determined to be blighted a few years ago, but now it is improving. The property is owned by a developer who is active in improving the building. Ms. Garcia advised the email reads as if the IDA cannot move forward if the building is not designated as blighted by the Planning Commission by Resolution. The Borough's planning Commission to her knowledge has never passed any Resolutions. Solicitor Margle advised the Planning Commission cannot pass a Resolution; it would have to come from Borough Council.

Solicitor Margle advised Council of a section in the Borough code that reads as follows: In the event that Borough Council determines that the lack of attendance of any Council member is creating an issue with the Administration of Justice and the Administration of the Borough, Borough Council may move to determine as a result of the failure to attend regularly scheduled Council meetings that the position is effectively vacant. A motion was made by Ms. Gable to allow the Solicitor have a ten-day notice served to Mr. Palinkas, giving him the opportunity to attend a scheduled hearing before Borough Council. Seconded by Mr. Bracken. A roll call vote followed. Yes votes cast by Ms. Allen, Mr. Bracken, Mr. Burke, Ms. Gable, Mr. Figueroa, Mr. Lipari, Ms. Muzac and Mr. Wacik. Motion passed with an 8-0 vote.

A motion to schedule the Hearing on February 27, 2025, made by Mr. Bracken. Seconded by Mr. Lipari. A roll call vote followed. Yes votes cast by Ms. Allen, Mr. Bracken, Mr. Burke, Ms. Gable,
