COMMUNICATIONS AND PETITIONS:

Mr. David Ney of the Wilson Baseball/Softball Association advised Council that the association received a \$25,000 grant for improvements to Jeffrey field. The funds will be used to replace the netting around the batting cages. The old netting will be fixed and placed along the 12-foot fence in the rear of the batting cages to prevent balls from going past the fence. The trees along the batting cages will be trimmed as well. Mr. Ney requested Council's permission to use Public Works to complete the work, estimating the work to be completed in about a day and a half. A motion to approve was made by Mr. Bracken. Second by Ms. Allen. A roll call vote followed. Yes votes cast by Ms. Allen, Mr. Burke, Mr. Bracken, Mr. Figueroa, Ms. Gable, Ms. Hurd, Mr. Lipari and Mr. Wacik. Motion passed with an 8-0 vote.

Ms. Garcia advised Mr. Redington of the Meuser Library requested Council's permission to close N. 18th Street from Northampton Street to the Church Street alley for the Annual Book Fair on September 6, 2025, from 9 am – 3 pm and September 7, 2025, from 9 am – 2 pm. Ms. Garcia advised that the Borough was awarded a \$70,000 grant for Sanitary Manhole Rehabilitation, which requires a 15% match to be paid from Sewer funds. She stated of the three bids received for the project, the lowest bid of \$33,725 was submitted by Advanced Rehabilitation Technologies. The Borough Engineer has fully vetted the bidder, and awarding the contract to the lowest bidder will enable the rehabilitation of additional manholes within the project budget.
