Nominations were taken for Council President. Ms. Gable nominated Mr. Burke. Mr. Figueroa nominated Mr. Bracken.

Roll call vote for Mr. Burke: Yes votes cast by Mr. Burke, Ms. Gable and Ms. Hurd. No votes cast by Ms. Allen, Mr. Bracken and Mr. Figueroa. Ms. Cooper abstained. Vote was 3-3-1.

Roll call vote for Mr. Bracken: Yes votes case by Ms. Allen, Mr. Bracken and Mr. Figueroa. No votes cast by Mr. Burke, Ms. Gable and Ms. Hurd. Ms. Cooper abstained. Vote was 3-3-1.

Mayor Barrett broke the tie by voting Yes for Mr. Bracken.

Mr. Bracken took the seat of Council President. Mayor Barrett handed the gavel to Mr. Bracken.

Nominations for Council Vice President were taken. Ms. Allen nominated Mr. Figueroa. Ms. Gable nominated Mr. Burke.

Roll call vote for Mr. Figueroa: Yes votes cast by Ms. Allen, Mr. Bracken, Mr. Figueroa and Ms. Hurd. No votes cast by Mr. Burke and Ms. Gable. Ms. Cooper Abstained. Vote was 4-2-1

Mr. Figueroa took the seat of Vice President.

Nominations for Council President Pro tem were taken. Ms. Hurd nominated herself should no other nominations be made. Ms. Allen nominated Ms. Gable.

Roll call vote for Mr. Gable: Yes votes were cast by Ms. Allen, Mr. Bracken. Mr. Burke. Mr. Figueroa, Ms. Gable and Ms. Hurd. Ms. Cooper abstained. Vote was 6-0-1.

Ms. Gable took the seat of Council President Pro tem.

Mr. Burke made a motion to adjourn at 6:22 pm. Second by Ms. Hurd and Council concurred.
